## MESSAGE FROM THE SELECTMEN

*To the residents and friends of Vienna:*

**T**he Town of Vienna has chosen John Sexton, Appraiser/Assessing Agent from Cole Brook Appraisal Company, to complete our property revaluation. His fee is \$31,000 plus yearly pick-up fees, which will be determined later.

Cole Brook Appraisal will begin visiting every property in Vienna as soon as August 2006 and will complete the job by June 1, 2007.

The assessing agent will inspect the interior and measure the exterior of each dwelling and building in Vienna. The Town asks that property owners cooperate by allowing inspection of the interiors of each building. By allowing this inspection the property owner can be assured that the physical property data used by the company for the new assessments is as accurate as possible.

After the revaluation is completed, property owners will be notified by mail of their new assessment. Mr. Sexton will then establish a time schedule to meet with anyone who may question their new assessment. All this will be done before the actual tax bill goes out.

- 5) Agent Dick Scott from Kyes Insurance came to go over our 2006-2007 town policies. Need to get list of fire truck drivers, licenses etc. Also need serial #'s on boat and motor.

- 1) Junior Meader gave us a report on the seeding of ditches. All went well. Had a discussion on what we want to do this year concerning paving on the Tower Rd. Also discussed Davis Rd. condition. We will look at rebuilding Davis Rd. with reclaim getting it ready for tar. Junior Meader will get us an estimate to do this. If we don't

work on the Tower Rd. this year we can do a lot of rebuilding of other paved roads.

- 2) Read minutes from 5-16-06. Accepted.
- 3) Received \$750.00 check for the Lake Warden's account from a grant from Lakes Environmental Association. (D.E.P. program for invasive plants education and prevention.)
- 4) Donna Hays from Maine Equalization brought property cards back from all permits (pick up work).
- 5) Dodi has finished most of the changes from Creston's list of Tax transfers and splits, etc. and will get everything to Connie. The 2006 Tree Growth valuations will be calculated by Connie's computer program. Everything should be ready for the Tax Bills June 1<sup>st</sup>.

**Selectmen's Meeting May 30, 2006**

Present Dodi, Chris, Brian, Steve Lilley, Linwood Meader, Jr.

- 1) Read Minutes from 5-23-06. Accepted.
- 2) Linwood reports that he is getting prices to fix the Davis Rd. He will also be repairing a few washouts on the Kimball Pond Rd.
- 3) All but 2-3 updates on property cards done. Dodi is going to sit down with Connie and go over the changes with her.
- 4) Homestead Exemption Tax Information and Ratio Declaration Reimbursement Application is due June 1<sup>st</sup>. Vienna's certified ratio will be 74%. Selectmen signed it and mailed it.
- 5) John Sexton (Appraiser/Assessing Agent) will meet with us June 6<sup>th</sup> to talk about the revaluation.

**Selectmen's Meeting June 6, 2006**

Present: Dodi, Chris, Brian, Steve Lilley, Linwood Meader, Jr.

- 1) Read Minutes from 5-30-06. Accepted.
- 2) Linwood's Report:
  - a. Got letter from the state to check on our speed limit signs.
  - b. Linwood will check on our signs. If we need any we will have to order them and get them put up.

- c. Need to put 15" culvert by Joe Lord on the Kimball Pond Rd.
  - d. Estimates on road repairs from Lenny Meader. We decided to do Davis Rd. 1<sup>st</sup>, Beck Rd. 2<sup>nd</sup>, and Egypt Pond Rd. 3<sup>rd</sup>.
- 3) John Sexton from Cole Brook Appraisal Company gave us a quick overview of his experience and a written resume. Talked with him about how we would go about setting our standards. Could start in August, be done by February 2007. Approximate estimate \$30,000. He will submit a written estimate by next week.
  - 4) Went over bills and signed warrant.

- 1) Read Minutes from 6-6-06. Accepted.
- 2) Linwood's Report:
  - a. Started on Davis Rd. project. Mason Rd has been graded. Stream Rd. has been graded and rolled.
  - b. Linwood has been patching the Egypt Pond Rd.
  - c. New "Equestrian" area sign has been put up on Klir Beck Rd.
  - d. New speed limit signs have not been ordered yet.
- 3) Signed Software Product Agreement with Trio Software Corp.
- 4) Signed Maintenance Contract with Transco for the Town House copier.
- 5) Ed Kohtala and Herschel Rackliff asked if we could get some flag holders for Veterans grave markers. Chris will check into it.
- 6) First meeting of the "Town House Committee" will be Monday, June 6 at 6:00 pm at the Town House.
- 7) Discussed the 2 quotes for complete revaluation of all properties. We will be talking to both companies to clear up some inconsistencies in the bids.
- 8) Chris reported that he, as a selectman was served with notice of a lawsuit on June 17, 2006. He brought copies of the complaint "Darrell R. Hall, Carol R. Hall, D & C Logging, Plaintiff v Town of

Vienna, Doris Thompson, Randall Carl, Chris Smith, Defendants.” The complaint alleges wrong doing on the part of the town and selectmen during the awarding of the 3 year snowplow contract in 2005. The contract was originally awarded to Darrell “pending meeting insurance and bonding requirements”. When Mr. Hall told the Selectmen he was unable to get bonding, the contract was awarded to the other bidder, Meader’s Construction. Dodi will contact Dick Scott at Kyes Insurance about coverage.

The town must respond to the court by July 17.

- 9) Fire Dept. (Steve and Belinda Lilley) will take over the scheduling of the Community Room at the end of August.
- 10) Reviewed and signed Warrant.

**Selectmen’s Meeting June 27, 2006**

Present: Dodi, Chris, Brian, Ed Collins, Creston Gaither, Misty McKechnie, Matt Moore

- 1) SAD 9 School Budget Assessment for Vienna for June 2006-July 2007 is \$382,728.00. The \$32,236.59 monthly payment is around \$500 less per month than last year.
- 2) Second Tax Bill will go out the end of August.
- 3) Ed Collins and Creston came to discuss one of Ed’s deeds. Creston has determined that Ed has been taxed for a parcel of land that is actually owned by David Marstaller. Ed will receive a three year tax abatement. We will be sending a supplemental tax bill to Mr. Marstaller.
- 4) Ervin Bean submitted his mowing bid. He also expressed his concerns about the way it has been done in recent years.
- 5) Matt Moore, Lake Warden and 3 others from Flying Pond Association and Parker Pond Association to talk about Mt. Vernon’s contributions. There was a discussion of Matt’s job description. We also talked about the condition of the trailer. “It is dangerous.” Brian will call Rob at Clarks Marine about finding us a used trailer for the tri hull.
- 6) Misty McKechnie asked if there was town money available to pay for a first responder’s course through the Rescue Squad. She says that the town of Mt. Vernon paid for two people from

Mt. Vernon. Misty will talk to Pat Rawson about her payment. The Town of Vienna gave the Rescue Squad \$3000 this year.

- 7) Dodi reported on the Town House Committee Meeting. Ruth Dunbar from Bangor Savings was here to discuss the Waugh Trust. The town house committee members are as follows: Helen Wilkey, Libby Harville, Burton Gilman, Norma Wing, Peg Lang, John Derbyshire, Judy Dunn, Gloria Kelley, Edwin Kelley, Sue Burns, and Jim Gajarski. They agreed to hire a building inspector for the town house and proceed with needed repairs. The selectmen agreed that they would proceed with painting the roof (the contractor has already been hired to do the job.)
- 9) Dodi reported that she had spoken to Dick Scott about the Hall lawsuit. She was contacted by Daniel Morrison of Massamont Insurance and told that the town policy does not cover contract disputes. She then contacted Stephen Langsdorf at Preti Flaherty. The selectmen agreed to hire Mr. Langsdorf to defend the lawsuit for the town. The selectmen deny any wrongdoing in the matter.

**Selectmen’s Meeting July 3, 2006**

Present: Dodi, Brian

- 1) Went over bills and signed Warrant.
- 2) Discussed the role of the Vienna Town House Committee.
- 3) June State Municipal Revenue Sharing Distribution: A mistake was made last month. We were over paid by \$25.04. This amount will be deducted next month.
- 4) Received “Mail Review for General Assistance”. Dodi will complete and return it to the State.

**Selectmen’s Meeting July 11, 2006**

Present: Dodi, Chris, Brian, Junior Meader, Steve Lilley, Phil Gregory, Norma Wing.

- 1) Read Minutes from 6-27-06 & 7-3-06. Accepted with changes.
- 2) Steve Lilley dropped off paperwork for Maine State Federation of Fire Fighters Insurance.

- 3) Vienna Fire Dept. received a grant of 4 mobile radios and 4 hand held units.
- 4) Phil and Norma came to talk about online auto re-registration on the town website. The selectmen will meet with a representative from the state office to discuss the program. Other aspects of the website were also discussed.
- 5) Norma reported that she is soliciting for paying ads to put into the Vienna newsletters. This will help pay for the paper and postage.
- 6) Linwood reports road repairs are moving along nicely.
- 7) John Archard has informed us of two violations of shoreland zoning. Letters are being sent to the property owners. They have 60 days to appeal.
- 8) Signed Pole Location Permit on Seavey Rd.
- 9) MMA has informed us that we can not enter into a contract with the town of Mt Vernon for Lake Warden Services without the vote of a town meeting. We will inform the Lake Associations and meet with them at a later date.
- 10) Chris will buy the roof coating and inform Barry to get started anytime the weather permits.
- 11) The selectmen agreed to purchase a new boat trailer from Clarks Marine for \$1000.

**Selectmen's Meeting July 18, 2006**

Present: Dodi, Chris, Brian, Linwood, Jr., Steve Lilley

- 1) Read Minutes from 7-11-06. Accepted as amended.
- 2) Linwood is going to check with Marti on how much money we have left in the road accounts. We also asked Linwood about a statement that we got from Lane Construction. Dodi has tried to get in touch with them for a copy of the original invoice.
- 3) Scott Landry came by and paid the town \$1500 for a parcel of land down off the Stream Rd. This is the property (Map9, Lot 5) that was posted for sale twice with no bids received. A quit claim deed was issued to Mr. Landry.
- 4) We signed Maine DOT Certification for Improvements of public roads. We will be receiving \$28,432.00 this year which goes to the paving account.

- 5) The town of Vienna has received its 2006 Kennebec County Tax Bill. \$47,934.89 - due in full Sept 1, 2006.
- 6) John Sexton, appraiser/ assessing agent came in to talk to us about revaluation of the town of Vienna. We went over some of the finer points of the estimate. Selectmen voted 2-0 to hire John Sexton for the job for \$31,000. Chris recused himself from the vote as he has a working relationship with Mr. Sexton. The fee for the yearly pick-up work will be determined later.
- 7) Ed Collins Tax Abatement has been processed for the warrant.
- 8) Reviewed and signed the Warrant.

**Selectmen's Meeting July 25<sup>th</sup>, 2006**

Present: Dodi, Chris, Brian, Linwood Meader, Jr., Marti Gross, Laura Reville, Matt Moore, and Mike Rogers.

- 1) Read minutes from 7-18-06. Accepted as amended.
- 2) Linwood reports that when we replace culverts on the Cumner Rd., we need to close the road for the day. He will notify the Fire Department and Rescue when the time comes.
- 3) We received the draft of the 2005 audit from auditor Stephen Hopkins. The final copy will be finished in August.
- 4) Brian will call Brian Keezer at DOT about the speed limit by the boat ramp on Rt. 41 in Mt. Vernon.
- 5) Matt, the Lake Warden was in to discuss where he can patrol on Parker Pond. Nothing has changed until we can sign an intergovernmental agreement with Mt. Vernon. There will be an article in the 2007 March Town Meeting warrant asking for authorization to do so. We went over his account budget with him. He reported that the new boat trailer is a great improvement. Matt expressed his concern that he feels he is not getting a lot of support from the fire department concerning the boat. He also reported on an incident at the boat landing between the milfoil inspectors and an extremely rude Vienna resident.
- 6) Dodi received a copy of the original mystery invoice from Lane Construction. The invoice was

It would not, it is NOT a law, ordinance or zoning. It's just a picture of what residents want for Vienna


#### ✦ What would it mean it me?

## The Mill Stream Grange

**I**t was on June 18, 1947 while preparing for a Farm Bureau meeting that Dorothy Waugh made the remark that she wished that a Grange might be started in Vienna. It was quickly seconded and discussed throughout the day by members who were very enthusiastic about the idea.

Not sure quite how to begin, Hazel Bean suggested a letter be sent to two veterans of Grange work, Allison P. Howes of Pittsfield and Nellie L. Haskell of Auburn. Freda Kelley drafted the letters. Nellie and Allison both forwarded their letters to then Deputy C.C. Chretien. He came to Vienna to see what was the cause of this sudden enthusiasm.

The first meeting was held at the Union Hall on August 8, 1947. Forty-four people became Charter Members that evening and took their First and Second Degree obligations. Clarence Bean was elected Master and Clyde Waugh Overseer.

The name Mill Stream Grange was chosen and it was decided to hold the meetings the first and third Fridays of each month.

Before the end of the first year six more people expressed interest in becoming members, bringing the rolls to half a hundred.

On September 13, 1966 the school house in Vienna Village was purchased from School Administrative District 9 by Chester H. Bean, George Weiss, and George Heddendorf in their capacity as all of the members of the executive committee of the Grange.

Today, there is still a great deal of enthusiasm for the Mill Stream Grange which helps build a sense of community and forges solid connections between neighbors. **It continues to meet on the first and third Friday of every month with a Pot Luck Supper at 6:30 pm**

**and the Business Meeting and Program at 7:30 pm.** It's participation has grown to nearly one hundred members. Thirty to forty members come to each meeting to enjoy programs like the Annual Minstrel Show written by Jeannette Daly and the comedy of Robert Skogland, "The Humble Farmer" of Maine Public Radio fame. The second time Robert came to the Grange he said he came back to tape the hearty laughter for his website! Other programs have included information on the Medicare D Program, Maine's last log drive, ice cutting on the Kennebec River, genealogy, the animal shelter, organic farming, feeding wild birds, habitat for humanity, throwing clay pots and guitars, as well as slide shows of trips to the Galapagos Islands, Ireland, England (by canal boat) and Africa. There have been games like Hide & Seek, Guess the Tool, and relay races. You never know who or what will show up for a program, but they are always good! It is a friendly bunch of people who enjoy sharing a good time together.

New members are always welcome! If you are interested in learning more, talk to a current Grange member, join them for a Pot Luck Supper or contact Gay Anderson, Master at 293-2679 or Allen Harville, Overseer at 293-2362.

Moving more in our daily lives is one of the simplest ways of making a change to living healthier and feeling better. It doesn’t always mean joining a gym or running a mile or two every day. We can add more movement to our lives by choosing stairs over an elevator, by parking further from the door in parking lots, or by taking a couple of extra trips to the garden.
