MESSAGE FROM THE SELECTMEN

To the residents and friends of Vienna:

Another town meeting is behind us. And spring is here, maybe. The budget was passed as recommended with the following exceptions:

Article 14: To see if the Town will vote the raise and appropriate the following sums for general government.
Community Building:
Amended to \$5000 plus carry the balance.

Article 28: To see what sum the Town will raise and appropriate for the Town of Mt. Vernon for the Rescue Squad. Recommended: \$3,000. Amended to \$3500.

Article 52: To see what sum of money the town would raise and appropriate to support the winter recreational trail system (Submitted by the Vienna Mountaineers). Requested: \$1000 Article failed to pass.

Because of these changes the total raised by Appropriation at Town Meeting is \$431, 441.

- 1) Read Minutes from 1-29-07. Accepted with changes.
- 2) Chris called Kristen Collins at MMA concerning the ATV Clubs gaining access to McGaffey Mountain Road. Ms. Collins has informed Chris that unless a road has been declared abandoned before 1965 that the road is still considered a public right of way. Chris will file the information received from MMA on file, and will give a copy of the info to Chris Courier.
- 3) Accepted and signed Warrant #3.
- 4) Ernestine Emery came in to go over the cemetery budget for the town report. The Cemetery Committee is requesting \$5500.
- 5) Dan Onion, Wayne Whittier, and Lidie Robbins from the Lakes Committee came in to go over the Lake Warden budget for the town report. They are requesting \$1500 plus carry the balance.
- 6) Went over year end road figures with Linwood. Selectmen agreed to ask for increases in all Road Accounts.

February 20, 2007

- 1) #81 Fire truck, 1991 Ford has failed its pump test. The 1250 G.P.M. pump is now only pumping around 850 G.P.M. (about 68% capacity). The cost of this rebuild could be as high as \$18,000. If the gear case is good this cost will drop. There are no immediate plans for repair. For now the truck will only be used for hauling water and pumping water into other trucks when called to a fire. The selectmen received a copy of the full report from Reliance Equipment.
- 2) Read Minutes from 2-13-07. Accepted with changes.
- 3) Dodi reported that she delivered the draft of the Town Report to

- Pettengill Printers in Leeds on Monday.
- 4) Dodi attended the Town House Committee meeting on 2-19-07. The Committee has voted to hire the an architectural firm of Holt & Lachman to go forward with plans for preserving the Town House and possible additions. The committee has requested that the selectmen put the responsibilities of the town house committee in writing. On Saturday, March 24th Trish Leighton, RN, volunteered to attend the LaGrange Café at Mill Stream Grange from 9 til 11 a.m. and do blood pressure checks for anyone who was interested. Nine residents from Vienna took advantage of this free service. We will be scheduling more of these blood pressure checks in the future. The frequency will depend on the interest of the community. So, if this is a service you would like to have continue, please look for our notices posted in the Post Office and take advantage.

As a member of the Healthy Futures Board, I have learned that Vienna now has a Health Advocate, Karin Kroot, RN. Karin will be attending our blood pressure checks when she can and will talk with us about what other services she can provide to Vienna Residents.

I am offering a Smoking Cessation program beginning May 1 at the Vienna Community Room. I will be there every Tuesday night from 6 to 7 and will continue to provide this service as long as there is interest. If there are any questions, please call me at 293-2316.

Please feel free to use me as a resource to get your health questions answered. If I can't give you the answer, I will find out who can.

- 1) Accepted and signed Warrant #5.
- 2) Tim and Gail Seamon came in to check on a parcel of land that Tim bought from Frank and Kathy Berry. The deed was recorded after April 1st of 2006 so the name change has not been done yet.
- 3) Dodi and Marti did the LD1 worksheet to determine the tax levy limit for 2007. That figure is \$211,584. If the requested budget is approved we will be going over the property tax levy limit by \$48,160. This will be voted on in article #5 at Town Meeting.
- 4) It was agreed that Chris Smith will look for a floor buffer (community room) at the State surplus store in Augusta. If he does not find one before town meeting he will get a one time rental and continue to check surplus.
- 5) The SAD #9 School Board of Directors, by a vote of 10 in favor and 0 opposed, have adopted a resolution opposing Governor Baldacci's school reorganization plan. Copies of the six point resolution are available at the townhouse.

March 13, 2007

Present: Dodi Thompson, Chris Smith, Brian Church, Donald Tibbetts, Connie Smith. John Sexton, Jeff Lunsford, Mike Rogers, Ernestine Emery, Lionel LaLiberte, Harold Bean, Marilyn Bean.

- 1) Donald Tibbetts was sworn in for a three year term as Animal Control Officer. The new contract with the Franklin County Animal Shelter was signed.
- 2) Minutes from 03-06-07 were accepted with changes.
- 3) John Sexton, our assessing agent, was in to give the selectmen an update. He plans to have the revaluation completed by May 15th.
- 4) Members of the Cemetery Committee were in to discuss their plans for the year.

They requested any fill that we get from ditching. We see no problem with this: Chris will let Linwood know. There was a discussion about cemetery maintenance, mowing, trimming, etc.

- 5) Mike Rogers and Jeff Lunsford from the Maine Taxation office were here to do the sales ratio analysis on all property transfers for the last year.

March 20, 2007

- 1) Linwood reports that two culverts have sunk. He has marked them and filled them with gravel.
- 2) Approved and signed Warrant #6.
- 3) Norma Wing, Chair of the Town House Committee came in with the agreement between Holt and Lachman, Architects and Planners and the Town of Vienna, which was signed. The agreement is for a three phase plan for the Town House.
 - a) Maintenance and preservation plan.
 - b) Master plan-near future, safety improvements, bathrooms, etc.
 - c) Master plan-long term future, possible addition, etc.
- 4) John Archard came in to give selectmen a copy of the District Court Hearing on the Town of Vienna vs. Ridgley Fuller/Bradley

Googins. The court ruled in the town's favor that the treehouse must be removed. John also brought in a letter from Attorney David Sanders stating that the tree house has been removed. Fuller/Googins have paid all costs and fees connected with this ordinance violation.

- 5) Read minutes from March 13th. Approved with changes.
- 6) Selectmen agreed to seek a Tax Anticipation Note from TDBankNorth.

March 27, 2007

- 1) Selectmen went over the Tax Anticipation worksheets and application. The TAN will be for \$100,000 at a rate of 4.09% with a due date of December 31st.
- 2) Brian reported on a meeting he had attended about regionalization of dispatching which will affect the Vienna Fire Department. There will be a meeting held sometime in April for all Fire Departments and town officials in our mutual aid group to discuss this further.
- 3) Chris reported that the Stream Road is closed to all through traffic except those who live on the road.
- 4) Read minutes from March 20th. Approved with changes.
- 5) Approved minutes of tonight's meeting so they can appear in the newsletter.

As you gather for your Annual Town Meeting, I welcome this opportunity to share some of the work that has made me proud to represent the people of Vienna and all of Maine in the United States Senate.

As Chairman of the Senate Homeland Security Committee, I am pleased to report that Congress made real progress in 2006 to protect our nation, including major legislation that I coauthored to improve the security of America's seaports. I also led a bipartisan effort to pass chemical security legislation that, for the first time, requires security measures at more than 3,400 chemical facilities nationwide.


Following the flawed response to Hurricane Katrina, the Homeland Security Committee conducted the most extensive investigation in its history, and I coauthored legislation that reorganizes and reunites the federal government's preparedness and response capabilities to meet the challenges of all aspects of emergency management.

Congress last year passed many pieces of legislation I authored to improve health care, assist those in need, protect our environment, support our economy and our workers, and strengthen our nation's defenses. The Older Americans Act includes my amendment to establish transportation services for America's seniors. I led the successful fight to reject proposed cuts in Medicare home health and hospice payments, and to prevent prescription drug plans from removing a drug from their formulary during the plan year. I have secured increased funding for diabetes and Alzheimer's research, and for support services for patients and their families.

In 2006, I helped secure a record level of funding for the Low Income Home Energy Assistance Program (LIHEAP), and Congress renewed the tax deduction I authored for teachers who spend their own money on classroom supplies and my renewable energy tax credit. The landmark Postal Reform legislation I coauthored will ensure affordable rates and preserve universal service. Major Defense bills include my provisions to help secure the future of Bath Iron Works and the jobs of our skilled shipbuilders.

The Kennebec County Sheriff's Office continues to proudly serve the residents of Kennebec County as it has since 1799. The Sheriff's Office provides Law Enforcement and Corrections services to thirty communities in an 890 square-mile area.

Deputies responded to 11,302 calls for service during 2006. The Sheriff Office holds Sexual Assaults, Domestic Violence and Narcotics Investigations as its central focus. We continue to provide a ten-man Dive Rescue Team, a K-9 Team, Accident Reconstruction Investigators, Civil Service, Court Security, a D.A.R.E. program in twelve schools, and a twelve-man Drug Operations Team.

In 2006, Deputies executed 48 Drug Search Warrants, making 120 drug-related arrests for Trafficking in Cocaine, Heroin, Prescription Pills and Marijuana. The Sheriff's Office collaborates with other Law Enforcement agencies within the Central Maine area to apprehend drug traffickers. We are very committed to this effort.


In 2006, the Correctional Facility housed 3,652 inmates, which included 3 Murder-related defendants, 793 Felony-level crimes, 330 Narcotic Violations and 2,849 Misdemeanor Offences. Our Correctional Facility manages up to 250 Inmates per day. Through innovative programs such as Maine Pre-Trial, Day Reporting and Electronic Monitoring, the Inmates are effectively and safely managed, at a much-reduced rate to the Citizens of Kennebec County.

The Kennebec County Correctional Facility continues to be a leader in the State of Maine. During 2006, Inmate Work Crews worked on more than 42 community projects. During this community service work, 839 inmates performed work for County, Municipal, State, Non-Profit Groups and Veterans organizations. As a result of the extensive work programs and the reduction in inmate bed days, the citizens of Kennebec County realized a savings of \$539,308.

The Kennebec County Sheriff's Office, in cooperation with the Department of Conservation, Fedco Seeds, Johnny's Select Seed and volunteers, operates a twelve-acre Inmate Garden. This five-year-old project, on average, produces 50,000 pounds of produce annually. This produce supplements the 600 meals, which are served each day in our Correctional Facility

April and May Health Observances

Each month in the United States there are many health observances celebrated (not just one, but many). So I picked a couple that I thought would have some impact on most people because they deal with issues that are wide spread in our country.

April is Alcohol Awareness Month. The following are Warning Signs of Alcohol Abuse. If you answer "yes" to any of the following questions, you may have a problem with alcohol:

- Do you drink alone when you feel angry or sad?
- Does your drinking ever make you late for work?
- Does your drinking worry your family?
- Do you ever drink after telling yourself you won't?
- Do you ever forget what you did while drinking?
- Do you get headaches or have a hangover after drinking?

If you suspect that you might have a drinking problem, or you know someone who abuses alcohol, please contact SAMHSA's National Clearinghouse for Alcohol and Drug Information (NCADI) at 1-800-729-6686 or find a screening site located near you. The National Clearing House is the source for free publications that will provide you with additional information about the hazards of drinking alcohol.

May is Mental Health Month. You can help yourself, your family, and friends by knowing some of the warning signs that may indicate problems that warrant help. These are warning signs that may indicate problems that warrant help.

Undue, prolonged anxiety. This is an anxiety out of proportion to any identifiable reason or cause. A state of constant tension and fear, fastening upon first one cause and then another is a signal that help is needed.

Prolonged or severe depression. The "blues" is a natural reaction to life's ups and downs. Depression, however, causes persistent changes in a person's mood, behavior, and feelings. Five or more of the following symptoms indicate a need for professional evaluation: feelings of sadness or irritability; loss of interest in sex and activities once enjoyed; changes

in weight or appetite; changes in sleeping patterns; feeling guilty, worthless, or hopeless; inability to concentrate, remember things, or make decisions; fatigue or loss of energy; restlessness or decreased activity noticed by others; and thoughts of suicide or death.

Abrupt changes in mood or behavior. Unlike changes a person adopts for self-improvement, these changes reflect serious alterations in a person's normal habits or way of thinking. The exceptionally frugal person, for example, who suddenly begins gambling away large sums of money may be experiencing emotional problems.


Tension-caused physical problems. Physical complaints that arise from stress range from headaches to nausea to muscle spasms. These symptoms, including pain, are very real; only a physician can determine their origin. Because medical tests may reveal an organic cause, any persistent physical ailment should be checked by a doctor.

The Dowst Family - Old Vienna Storekeepers

Down through the years, Vienna has been home to many storekeepers, but arguably none as enduring as the Dowst family. Henry Dowst was born October 1817 in Vienna, son of Ozem and Betsey Burrill Dowst who had come here from Epsom, New Hampshire. Henry followed his father into farming, and in 1840 married Mary Jane Blackstone of New Sharon. Like most couples of their time, they were quite prolific giving birth to nine children, of which, three died before reaching adulthood. Of their six remaining children, all sons, four served in the Civil War.

Shortly before his boys went marching off to war, Henry opened a dry goods store on the southwest bank of the Mill Stream at what is now Town House Road in the Village. He surely must have missed their helping hands in his business endeavors, as he was left with only the help of Clarence Laforest a pre-teenager and Granville Blackstone barely school age.

- The eldest son, Dana Milton Dowst, served in Company E, 24th Maine Infantry and died of disease in 1863 at Bonnett Carre, Louisiana.
- The second son, Selden Manassah Dowst, served in the 4th Maine Light Artillery, and died of disease in 1865 at Washington, D.C.
- The third son, John Alanson Dowst, served in Company I, 1st Maine Heavy Artillery and was wounded at the Battle of Spotsylvania Courthouse. After recovering from his wounds in a hospital at City Point, Virginia, John married and relocated to Brooklyn, New York, where he owned his own business as a cider and vinegar manufacturer. He later applied for and received his war pension benefits, and died in Brooklyn between 1890 and 1900.
- Son number four, Henry Ferdinand Dowst, served in Company F, 12th Maine Infantry. After the war, he married and settled first in Boston and later in Bangor. He was the father of prolific writer Henry Payson Dowst. Dowst received his war pension benefits, and died in Bangor in 1929.

On Christmas Day of 1872, son number five,


Clarence Laforest Dowst, married Arrazina Allen, daughter of Benjamin F. Allen and Sarah B. Neal. The couple resided in Vienna and of their six children, only three lived to adulthood.

Exactly two months later, the youngest son of Henry Dowst, Granville Blackstone Dowst, died at the age of 16 years. Of nine Dowst children born, the only one remaining in Vienna was Laforest, who worked at the store with his father.

Henry continued operating the store until his death in 1895, when the store passed to Laforest.

Operations continued until Laforest died in 1915, and his two bachelor sons, Dana and Orville took over operations. Orville passed away in 1935. We are not sure exactly how long Dana continued in the business, but the store burned down on April 24, 1948. Dana passed away on September 28, 1948.

Thus, it would appear the Dowst family had the longest tenure of any storekeepers in Vienna, having operated successfully at the same location for three generations spanning well over eighty years. The Dowsts are buried in the Vienna Village Cemetery.


