FROM THE TOWN SELETCMEN

Report on Town Meeting:

All the incumbant town officials were reelected at the town meeting election held on March 12th.

The budget articles were all passed on March 13th as recommended with the following two exceptions:

Article 29 - To see what sum the Town will raise and appropriate for Winter Roadwork.

Recommended: \$158,000 Amended to \$148,000 and passed.

Article 34 - To see what sum the Town will raise and appropriate for the Waste Management Account.

Recommended: \$53,000 Amended to \$55,000 and passed.

The total appropriation amount for 2010 is **\$478,049.**

SELECTMEN'S MEETINGS

Selectmen's Meeting February 2, 2010

Present: Dodi Thompson, Chris Smith, Brian Church, Linwood Meader, Jr., Marti Gross

1. Reviewed and signed Warrant #3.
2. Linwood reports that most of the damage to our roads due to the heavy rains last week has been repaired.
3. Wayne Whittier came in to talk to selectmen about the town roads issues as a follow up to last week's meeting. It was clear that many townspeople were opposed to turning any paved sections of road to gravel at the time. The selectmen will be gathering more information on this issue and alternative paving materials, etc. Wayne has volunteered to take any information we gather and add it to his for a printed handout for future meetings.
4. The town received a

2. Dodi reported that Dan Onion has agreed to be the Town's new Health Officer.

Selectmen's Meeting

February 16, 2010

1. Reviewed and signed Warrant #4
2. Dodi reported that the Town Report has gone to the printer. The reports will be delivered to the Town House on Thursday, March 4th.
3. Dodi has gathered the tax transfer information, deeds, etc. and given them to Creston Gaither who will update our tax maps for 2010. He also creates the list from which we update the property cards per changes.
4. Linwood reports there are no major road problems at this time.
5. Marti and Dodi have begun working on the Town's Tax Anticipation Note application.

There are no minutes available for the February 23, 2010 meet-

ing.

Selectmen's Meeting

March 2, 2010

Present: Dodi Thompson, Chris Smith, Brian Church, Linwood Meader, Marti Gross, Connie Smith, Ed Lawless, Dan Onion, Lidie Robbins.

1. Reviewed and signed Warrant #5.
2. Linwood reports that the Stream Road has been repaired and is now passable.
3. The Selectmen appointed Ed Lawless to the Planning Board for a 3 year term
4. Connie Smith, Town Clerk swore in the following: Ed Lawless - three year term on the Planning Board; Dan Onion - three year term as Vienna's Health Officer.
5. Lidie Robbins and Dan Onion from the 30 Mile River Watershed Association met with the selectmen to update us on how the 2009 season went and what the group is planning for 2010.
6. Dodi reported that she met with John Sexton last week to go over two abatement applications that he has been working on. John has begun doing the assessing pickup work relating to new permits and property cards flagged from 2009.

Selectmen's Meeting

March 9, 2010

Present: Dodi Thompson, Chris Smith, Brian Church, Linwood Meader, Jr., Marti Gross

1. Marti has filed the paperwork for the town's T.A.N. (Tax Anticipation Note) with T.D. BankNorth. The note amount will be \$100,000.00. The note will be issued

on Tuesday, March 16, with an interest rate of 3.20%. The total interest will be \$2568.89 with the bank paying the legal fees. Lee Bragg of Bernstein-Shur will act as bond counsel.

2. Linwood has posted all the roads. There are some pot holes forming on the Tower Road. He will take care of them as soon as the weather permits.
3. Peg Lane came in and expressed her concerns about the broken guard rail on the Tower Road. This guard rail was damaged by the snow plow earlier this winter. The plow contractor will be repairing the rail this spring as soon as the ground dries up.
4. State Representative Pat Jones came in to meet with selectmen. She gave us an update on the House of Representatives and state budget cuts which affect municipalities. There was also a discussion about the condition of Town House Rd (Rt. 41).

Selectman's Meeting

March 16, 2010

Present: Dodi Thompson, Chris Smith, Brian Smith, Marti Gross, Linwood Meader, Jr.

1. Reviewed and signed Warrant #6
2. Had some discussions about Town Meeting and the resulting budget. The total amount appropriated was \$478,049.
3. Linwood reports that he checked all the town roads today and saw no immediate problems. The frost is just about out of the dirt roads.
4. The selectmen signed an engagement letter with Stephen T. Hopkins, CPA, for auditing services for the year ending December 31st 2009.
5. Reviewed and approved Selectmen's Meeting Minutes for all of February and the first two weeks of March.

Planning Board Minutes

MINUTES OF THE REGULAR MEETING OF THE VIENNA PLANNING BOARD HELD JANUARY 27, 2010

The meeting convened at 7:00 PM at the Town House. Members present were Waine Whittier, Alan Williams, Nanou Laliberte, and Creston Gaither. Minutes of the December 23 meeting were read and accepted.

Howard Charles' forest management plan for the Potter parcel on Tower Road (tax map 5 lot 14) was reviewed along with the Resource Protection and Timber Harvesting Ordinance (RP/THO). Erosion control and regeneration plans required by the Ordinance were not explicitly labeled as such. It was agreed that, by stipulating "best management practices" and "selective harvesting," the management plan meets, respectively, the erosion control and the regeneration plan requirements. It was agreed that the permit should state these assumptions. The board then voted to authorize Creston to issue a RP/THO permit for this harvest.

Jon Hambrick's application for renewal of his Sept. 24, 2008 Shoreland Zoning Ordinance (SZO) permit was reviewed. The board then made findings of fact as per Sect. 16.D. of the SZO, found the proposal conforming (provided that the same conditions outlined in the 2008 permit are met), and authorized Creston to issue the usual SZO permit by letter, subject to said conditions.

Repeal of the RP/THO was discussed. Creston and Alan's e-mail exchanges with District Forester Morten Moesswilde were reviewed. In general Mr. Moesswilde recommends repeal, due to the Ordinance's redundancy (given current State requirements), the out-datedness of some of its provisions, and some enforcement concerns. The board voted unanimously to authorize Waine to draft a repeal article for Town Meeting.

Creston will reorder the 2010 Land Use Pamphlets, having received no response to the board's earlier inquiries.

Waine expects to miss the board's February meeting.

The meeting adjourned at 8:00 PM.

MINUTES OF THE REGULAR MEETING OF THE VIENNA PLANNING BOARD HELD FEBRUARY 24, 2010

The meeting convened at 7:10 PM at the Town House. Members present were Alan Williams, Nanou Laliberte, and Creston Gaither. Also present was Ed Lawless. Alan was elected Acting Chairman in Waine Whittier's absence. Minutes of the January 27 meeting were read and accepted.

Ed volunteered to join the board. Creston will notify the selectmen of this.

Creston did not have the recently issued timber harvest permit for the Potter parcel on Tower Road (tax map 5 lot 14) but will bring it next month.



Youth Conservation Corps Projects Needed

The 30 Mile River Watershed Association (30MRWA) is seeking project sites for this summer's Youth Conservation Corps (YCC) work in our watershed. The YCC's mission is to preserve and improve water quality by addressing erosion and runoff issues on watershed property. The YCC provides all project labor free of charge; the landowner is responsible only for the cost of materials.

To arrange a site visit, please contact 30MRWA Executive Director Lidie Robbins at info@30mileriver.org or 293-2181. We are available to look at specific problems or simply to review your property and suggest ways to reduce your impact on the lakes.

All work is strictly cooperative with landowners and no sites will be identified for enforcement action. Our purpose is to encourage good stewardship of our lakes.

Summer Jobs

We are currently seeking summer employees for our Courtesy

Boat Inspection (CBI) and Youth Conservation Corps (YCC) programs. YCC members work as a team to complete shoreline stabilization and erosion control projects. Crew members and a crew leader are needed. Applicants should be willing to perform physical labor and have an interest in environmental stewardship. The program will run for eight weeks during June, July and August – four days per week.

Courtesy boat inspectors are the "first line of defense" against invasive aquatic plants, by preventing plant fragments found hitchhiking on boats and trailers from entering our lakes. CBIs work at boat launches throughout the watershed, talking with boaters and inspecting their watercraft as they launch and remove their boats. The program runs Memorial Day-Labor Day, with weekends and holidays being the primary coverage times needed.

Applicants may be able to combine both YCC and CBI positions for full-time work. For complete job descriptions and an application, visit www.30mileriver.org. Application deadline is May 1st.
