Selectmen's Meeting September 14, 2010 The Selectmen will make a decision at our next meeting

1) Brian has been gathering quotes for a new computer system for the Town Clerk's office. We have received (2) quotes.

B) From The Evans Group in Mt Vernon Hardware, software & installation \$1413.56

Note: new software includes: Windows 7 Pro, Microsoft Office Business, Anti-virus software with automatic updates & Firewall & Spybot software.

GREETINGS FROM THE VIENNA POST OFFICE!

- Thank you for your support! Many people don't realize that where they buy their stamps and ship their parcels does make a difference. Each office's revenue and expenses are tracked. If the Postal Service ever decides to close Post Offices, they will be looking at those figures. When you go to usps.com to buy stamps or create Click 'n Ship labels, etc. if the computer is in Vienna then Vienna Post Office will get credit for that revenue as well. Out of Towners can buy stamps from the Vienna Post Office with our Stamps by Mail brochures. Ask us for some if you would like to send any to your out of town friends and relatives -- either at the Post Office or we'll deliver them to your rural route mailbox.

- If you'd like a break from shoveling out your rural route mail box this winter you can rent a PO Box for the winter months only. Just \$22.00 for 6 months. (If closed within

1st 3 months there is a refund -- only \$11.00 for 3 months!)

- Did you know you can get postage paid envelopes at most pharmacies to mail in your unused medications? This helps to prevent groundwater contamination and create a safer home environment. There are a few enveloped at the Vienna Post Office.

- The current display in the Display Case in our lobby is: "Free Stuff"! Savvy shoppers are doing their Christmas shopping here. Clean out your attic, basement, shelves . . . and bring them in for someone else to take home and enjoy. (No books, clothes, appliances.) If you see anything in the case that you want, it's yours! Just ask us to fetch it out for you!

2) Linwood reports that he will begin to "put up" the winter sand and salt on Monday, September 30th. He also reports that he has been grading the town's dirt roads; this will be the final grading before winter.

3) Discussed and distributed mail.

4) The Selectmen ordered the new computer for the Town Clerk's office. We voted to purchase it from the Evan's Group. The deciding factor was that the Evan's Group is also knowledgeable with Trio, the town's property tax software.

Selectmen's Meeting
September 28, 2010

Present: Dodi Thompson, Chris Smith, Brian Church, Linwood Meader, Jr.

1) Linwood reports that the beavers have been busy building a dam across the road from the Parker Pond boat landing. Linwood has taken said dam apart. Linwood also reported that the Town's winter sand and salt has been "put up" for the season.

2) The Town received a dividend check from the Maine Municipal Association for \$143.00. This is a result of a "Good Loss Experience" concerning our workman's compensation insurance.

October 5, 2010

1) Reviewed and signed warrant #19.

2) Lew Emery came in to request a copy of tax map #11.

3) The Selectmen posted on the door of the Town House that we will be voting on the 2010-2011 General Assistance Ordinance Appendices A, B and C at our next meeting on October 12th.

4) Linwood reports that the beavers have plugged the culvert at the Parker Pond boat landing again. We will now have to hire someone with a pulp loader to unplug this culvert.

5) Ernestine Emery and Annie Tibbetts came in to have us sign two (2) Cemetery Lot Conveyances. Annie then notarized them.

6) Dodi spoke Melinda Turner at Riverside Disposal about submitting a proposal for a new 3 year contract for trash and recycle pick-up. Riverside responded with a proposal for the next 3 years at the same price as 2010. The Selectmen voted unanimously to accept. The contract will be signed later this month.

3) John Archard came in and gave us a copy of a Consent Agreement/Settlement on two Shoreland Zoning Violations on a Kimball Pond property. The property owner paid a fine and the town's enforcement cost. The check was submitted to the treasurer.

Creston presented an e-mail he received from Ted Hunt regarding possible Shoreland Zoning Ordinance and/or plumbing code violations on Kimball Pond, noting that it had also been addressed to CEO John Archard. It was agreed that these are enforcement issues and thus outside of the Board's purview. Creston will notify Mr. Hunt of this.

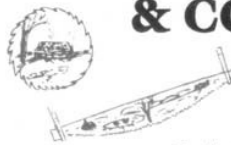
