3. Reviewed and signed Warrant #18 (\$73,884.64).
4. Selectmen will be ordering "truck entering" signs to be put up on the Tower Road near Troy Beans new garage. This is a safety issue with the garage being at the bottom of the steep hill and Troy has requested these signs for everyone's safety.
5. Dave Steven was awarded the winter sand contract for 2200 yards at \$4.40 a yard. The winter sand will be put up in November. 225 tons of salt will be ordered for the winter roads.
6. Selectmen voted to accept the MMA General Assistance – Appendices A-F for the period of October 1, 2018 to September 30, 2019.
7. Chris reported that Dan has graded the Klir Beck Road and Mountain Road and has replaced culverts on the Trask Road and the Kimball pond Road.

### **Mainers Urged to Sign Up for Free Disposal of Unusable Pesticides**

*Maine DEP and Board of Pesticides Control promote responsible disposal*

AUGUSTA—Unusable pesticides, such as weed killers (herbicides) and bug killers (insecticides), can be dangerous to humans, pets, and the environment. Pesticides can become unusable due to age, freezing or evaporation, or because their legal registration changes. Improper disposal of these products can contaminate land and water resources, including drinking water.

**Participants must pre-register by October 5, 2018. Drop-ins are not permitted.** Collections will occur at four sites: Presque Isle, Bangor, Augusta, and Portland.

Homeowners, family-owned farms, and greenhouses can dispose of unusable pesticides through the free Obsolete Pesticide Collection sponsored by the Maine Department of Agriculture, Conservation and Forestry's (DACF) Board of Pesticides Control (BPC) and the Maine Department of Environmental Protection (DEP). The program is funded through product registration fees; since 1982 it has kept more than 103 tons of pesticides out of the waste stream.

"Providing Maine residents with a free and easy solution to properly dispose of pesticides gives everyone an opportunity to make a positive impact on our environment and public health," said Paul Mercer, DEP Commissioner.

DACF Commissioner Walt Whitcomb is encouraging Mainers to seize this free opportunity. "It is not uncommon for people to find themselves with obsolete pesticides and not know how to dispose of them. It's important for the protection of the public, wildlife, and environmental health that they are dealt with properly and not thrown in the trash or down the drain."

## Planning Board News

### MINUTES OF THE REGULAR MEETING OF THE VIENNA

PLANNING BOARD HELD JULY 25, 2018

The meeting convened at 7:00 PM at the Town House. Regular members present were Wayne Whittier, Ed Lawless, Alan Williams, and Creston Gaither. Also present was contractor Scott Horne. Minutes of the June 27 meeting were read and accepted.

Scott presented a proposal to build a 24' x 36' camp with a deck on Ricci Viscusi's Flying Pond property depicted on tax map 11 as lot 11-H, on which the Board had met with Scott on May 23. Creston noted that he had observed a slope of approximately 24% on this lot with a hand-held clinometer when he surveyed it for Mr. Viscusi. Scott presented a text message authorizing him to represent Mr. Viscusi before the Board. He agreed to forward this to the Board in writing. Creston noted that the Shoreland Zoning Map which shows this lot as Limited Residential takes precedence over the definition of Resource Protection District found in the Shoreland Zoning Ordinance. Scott's site sketch was reviewed and it was agreed that it must be revised to correctly show the setbacks. Scott agreed to do this and said that a Subsurface Waste Disposal (SSWD) permit is in progress.

Contingent upon receipt of the documentation outlined above, and based on its site visit and

On Scott's sketch and verbal representations and on its site visit, and a favorable review of the flood hazard maps, The Board determined that the project as outlined above:

1. Will maintain safe and healthful conditions;
2. Will not result in water pollution, erosion, or sedimentation to surface waters;
3. Will adequately provide for the disposal of all wastewater;
4. Will not have an adverse impact on spawning grounds, fish, aquatic life, bird or other wildlife habitat;

5. Will conserve shore cover and visual, as well as actual, points of access to inland waters;
6. Will protect archaeological and historic resources as designated in the comprehensive plan;
7. Will avoid problems associated with floodplain development and use; and
8. Is in conformance with the provisions of SZO Section 15, Land Use Standards.

The Board voted 4 – 0 to authorize Creston to issue the usual permit by letter for the proposal, with these conditions:

1. Erosion control measures are to include best erosion control management practices, silt fencing, a permanent berm consisting of 2 feet of crushed stone; and a sediment basin;
2. A catch basin for driveway and roof runoff.

Scott added that he and his company are certified for best management practices in the Shoreland Zone.

DEP's letter to Wayne of July 19 and the order attached to it were discussed. Wayne will respond to it. It appears that the changes to the SZO which the Board recommended and that the Town adopted need not be altered until the next time the SZO is revised.

The Meeting adjourned at 8:00 PM.

## Planning Board News Cont.

### MINUTES OF THE REGULAR MEETING OF THE VIENNA

PLANNING BOARD HELD AUGUST 22, 2018

At 6:15 PM regular members Waine Whittier, Ed Lawless, and Creston Gaither met at the Harpines' site on Flying Pond, shown on Tax Map 10 as Lot 42, with regular Board member Alan Williams acting as the owners' representative. The owners' proposal to enlarge the existing deck on the existing camp with decks and a porch was discussed.

The Board's regular meeting convened at 7:00 PM at the Town House. The discussion of the Harpines' proposal continued. Page 4 of the Shoreland Zoning Ordinance was briefly reviewed. The new construction is to rest on posts and thus there will be no excavation; no trees are to come down. A number of erosion control measures had been observed in place during the aforementioned site visit. Alan will redraw his sketch of the proposal. He recused himself from the Board's formal deliberations in this matter.

Based on its site visit and on Alan's sketch and verbal representations, and a subsequent examination of the pertinent flood hazard map, the Board determined that the project as outlined above:

- 1) Will maintain safe and healthful conditions;
- 2) Will not result in water pollution, erosion, or sedimentation to surface waters;
- 3) Will adequately provide for the disposal of all wastewater;
- 4) Will not have an adverse impact on spawning grounds, fish, aquatic life, bird or other wildlife habitat;
- 5) Will conserve shore cover and visual, as well as actual, points of access to inland waters;
- 6) Will protect archaeological and historic resources as designated in the comprehensive plan;
- 7) Will avoid problems associated with floodplain development and use; and

- 8) Is in conformance with the provisions of Section 15, Land Use Standards.

It was voted 3 – 0 to authorize Creston to issue the usual permit by letter for this proposal, upon receipt of Alan's revised sketch.

The Meeting adjourned at 7:40 PM.

## Aging In Place from

September, 2018

Dan: George, I know from your recent columns that you are very interested in “aging-in-place” issues for both personal and public reasons. I’d like to hear a little more about why and how because as the health officer for both your and my adjacent towns and a boarded geriatric physician, I too have been working on ways to help seniors stay here in their homes and among their friends and acquaintances. Tell me what you’ve been doing.

George: Our rural communities are full of old folks, so that is a new and important focus for many of us, including those of us working on a new comprehensive plan for Mount Vernon. A group recently formed a committee to work on initiatives for the elderly. Townspeople appropriated \$1000 at the June town meeting for this new initiative. A few of us attended an AARP seminar on their programs for the elderly and were very impressed. Mount Vernon will be applying to join the AARP project soon. 200 towns are already participating in the AARP initiative that is called Building an Age-Friendly Community.

Dan: I’ve been working for the past 3 ½ years to establish a volunteer transportation system in our 2 towns and 3 contiguous ones. Four years ago, Sandy Wright and I happened to have coffee together at the Mt Vernon community center, where she told me that transportation solutions for seniors, who had had to retire from driving were the number one concern of a senior gathering at the local school. From there, she and I recruited a group of interested townsfolk, studied the issue, did some surveys of our seniors, and obtained a Maine Community Foundation 1-year planning grant. That grant let us pull together some focus groups to define the problem and explore some possible solutions, as well as hire Jo Cooper and a colleague from Ellsworth to consult with us about our plan. Jo has been a running service there for nearly 20 years. And, by the way, you probably know her brother Matt Dunlap, the secretary of state, who thereby is in charge of the Bureau of Motor Vehicles. Having served as chair of the BMV medical advisory committee for 5 years in the recent past, I know how interested they are in finding ways to help those whose health requires them to retire from driving themselves.

Out of that planning arose Neighbors Driving Neighbors, our 5-town volunteer driving service, which has now, after 2 ½ years has given over 1000 rides to local residents, mostly seniors who can no longer drive. Starting with about 20 drivers, we now have over 45 volunteer drivers. A couple startup grants from the Bingham Betterment Fund and the Bingham Program got us going and we now seem able to survive with donations and charitable contributions from individuals and local businesses. Two part-time, very modestly paid local contracted coordinators field the ride requests and find driver matches. We are now giving about 40 rides a month, and last summer gave over 60. Initially most rides were for medical appointments, but we’ve been able to grow the percentage for other social activities up to nearly 50%. Both are important, we think.

## From the Health Officer Cont.

George: Neighbors Driving Neighbors is a great project, and I thank all who are participating, especially you and Sandy. And yes, Matt Dunlap is a good friend of mine. AARP offers community challenge grants to create vibrant public places, and we hope to get a grant for our library, where we hope the addition will become just that – a vibrant public place – for all members of our towns, from kids to senior citizens.

Dan: I never realized, until I got old myself, how complicated it is to plan for contingencies. When will I need driving help. When with housecleaning? When with plowing? When with meals. Can I stay in my house, etc.? And how do I keep up with friends and find new ones as others pass on or move away? I admire your planning and think your example and explicit reporting are helpful to many. In the old days, and occasionally still, multiple generations living in the same or nearby houses made all these choices much easier, but such arrangements are getting rarer, with smaller families, and adult children having to move out of state to find work. Strong, innovative communities seem to find a way to broaden support beyond immediate family members, as I see with Neighbors Driving Neighbors. Ours is one such community to be proud of.

George: One project that we need to tackle comes from the Red Cross. A local volunteer comes to your home to check on your smoke detectors, and they replace them if that is needed. Both Wayne and Readfield participate in AARP's program. I have friends who volunteer for Readfield's Handy Helpers project, ready to help with things like moving furniture or taking things down from high shelves. With my illness of ALS, I must say it is wonderful to live in such a caring community, where many have volunteered to help Linda and me whenever we need help. Four friends came all winter to help Linda shovel. We are blessed.




