## Selectmen's Minutes

### May 26, 2020

Present: Chris Smith, Jeff Rackliff, Laura Church, Felicia Audett, Ed McCarthy, Lois Hinkley, Tim Bickford

1. Reviewed and dispersed the mail.
2. The selectmen read and accepted the minutes from the previous meeting.
3. The selectmen discussed Covid-19 and the Governor's response. Mr. McCarthy had a concern with people speeding past his home. He has had contact with the State of Maine about a radar sign and he will forward the contact information to us. Mr. McCarthy had concerns with some of the selectmen not wearing masks at the meeting. He is also concerned about

people not wearing masks at the Flying Pond Variety Store. We informed him that the store is located within the town of Mt. Vernon. Mr. McCarthy should speak with the Mt. Vernon selectboard.

The broadband committee is continuing to work on this and will send a consultant to talk with each of the six towns. The committee has decided the best option is fiber optic to each home. It was discussed and agreed to stay working on this as a group. We have six vendors to look at and consider. Two have responded with positive responses.
6. The selectmen reviewed and discussed an email received from Ed McCarthy. Ed has continued concerns about the selectboard's use of face masks.

### June 9, 2020

1. Reviewed and dispersed the mail.
2. The selectmen read and accepted the minutes from the previous meeting.
3. The selectmen and Dodi worked on the 2020 Mill Rate and worked on the HomeStead Exemption form.
4. Mr. McCarthy expressed concerns over people speeding past his home on Route 41 (just outside the village) in Vienna. The selectmen advised him to contact the Sheriff's Department and the State Police on this matter. Mr. McCarthy also expressed concerns over the wearing of face masks at the selectmen meetings. The selectmen directed Mr. McCarthy to the sign, located on the entrance, requesting anyone entering the Town House to wear a mask.
5. A citizen expressed concern over a covered dead end sign on the Cumner Road. The sign is going to be moved closer to the beginning of the road making it more visible.
6. Ed Lawless updated the selectmen on the broadband committees' progress. Joe Young, Chairperson for the Broadband Committee, will attend a future meeting to further update the selectmen on the process and to explain the next step(s).

### June 16, 2020

1. Reviewed and dispersed the mail.
2. The selectmen read and accepted the minutes from the previous meeting.
3. Reviewed and signed Warrant #12 (\$15, 206.94).
4. Mr. Young updated the selectboard on the Broadband process and informed them of the next steps.
5. Mr. McCarthy talked with the selectmen about people speeding on Route 41, how business is being conducted in Mt.Vernon at the Flying Pond Variety Store, and talked about people wearing masks during public meetings in Vienna. The selectboard continues to look into these matters.
6. Mr. Williams expressed interest in cutting wood from town owned property referred to as the "Old Dump". The selectboard has been advised the cutting of trees on town owned property would need to go out to bid. The selectboard will look further into this option of raising money for the town.
7. The selectmen will meet on Thursday, June 18, 2020 at 6:30p.m. to set the mill rate.

6. Inland Fisheries and Wildlife have inquired about improving the boat ramp at the Parker Pond boat landing. The selectmen will look further into this.

**July 7, 2020**

1. Reviewed and dispersed the mail.
2. The selectmen read and accepted the minutes from the previous meeting.
3. Reviewed and signed Warrant #13 (\$17,653.04).
4. The selectboard met with Diane Circo, Chief Planner of Inland Fisheries and Wildlife, and Wes Ashe, Fisheries Biologist for the State of Maine Inland Fisheries and Wildlife, at the Parker Pond boat ramp prior to the selectboard meeting. The purpose of the meeting was to look at the current boat ramp and parking area in order to come up with a plan on how to improve both the ramp and parking.
5. The Klir Beck Road dumpster is going to be re-set a little further away from the mail boxes, however, it will not be back to the Vienna shore.
6. The Road Commissioner is looking into ditching and water issues on the Mountain Road.
7. The selectmen looked at the assessment on a property, re-evaluated it, and wrote an abatement.
8. Meeting adjourned.

**July 14, 2020**

1. Reviewed and dispersed the mail.
2. The selectmen read and accepted the minutes from the previous meeting.
3. A resident wanted to know how to transfer property. The selectmen directed the resident toward the Kennebec County Registry of Deeds.
4. Fire Chief, Brian Church, discussed the use of the community room and the possibility of opening it again to public use. Discussion was held on charging a cleaning fee until Covid has been taken care of. The Selectmen agreed to continue to keep the building closed to public use until further notice.
5. The selectmen discussed the cutting of the town property known as the "Old Dump" property. This process would need to be put out to bid. The selectmen are considering this as a way to make money for the town.
6. The town is looking into a new code enforcement officer. Matthew Drost is considering an offer to work for the town.
7. A resident requested an abatement for his parents' taxes from 2019. The bank sent paperwork stating the 2019 taxes are unpaid and will have a lien placed on the property. The resident is concerned the bank will foreclose on the property.

4. The selectmen will meet with Matthew Drost on Thursday, July 23, 2020 at 5:30p.m. for an interview for the Code Enforcement Officer position.
5. The Treasurer has resigned and will end her service at the end of August 2020.

July 21, 2020 (contd.)

6. The selectboard discussed the previous complaints of a resident of people speeding on Route 41, in front of his house. The selectboard agreed to not get a speed radar sign due to lack of storage space and personnel to a) keep it maintained b) collect data and c) to keep it operational/charged. The selectboard has directed the resident via email and in person to contact the Sherriffs' Department and the State Police.
7. The selectboard has been asked to sign paperwork to acknowledge the need for faster internet in the town. The selectboard is in full agreement and furthermore agrees to support efforts to bring better

service to our community. The town has been working with other local towns to bring better service to the area.

## Planning Board Minutes

NO MEETINGS BETWEEN FEBRUARY & MAY DUE TO THE COVID-19 SITUATION

MINUTES OF THE REGULAR MEETING OF THE VIENNA PLANNING BOARD

May 27, 2020

- The meeting convened at the Town House at 7:00 PM. Regular members present were Waine Whittier, Alan Williams, Creston Gaither, Ed Lawless, and Tim Bickford. Minutes of the February 26 meeting were read and accepted.
- The Board discussed recent outconveyancing from the Craig property, known in recent years as Tax Map 10 Lot 22. The State Subdivision Statute, M.R.S.A. Title 30-A §4401, was reviewed briefly. The recent outconveyances, and another said to be proposed, do not appear to create the "three lots within a 5-year window" which would create a subdivision as outlined in the statute, as one is a conveyance to an abutter and another did not create a third parcel, and the proposed new outconveyance is a gift to a relative by blood, marriage or adoption. The Board voted 5 - 0 that that a subdivision requiring municipal review will not be created by the proposed third outconveyance.
- Creston will contact Matt Siegel to coordinate a site visit to his father-in-law's Flying Pond property.
- The Board agreed to try to resume regular meetings.
- Ed reported on the broadband committee. All 6 towns have agreed they want to pursue a fiber-to-the-home option and to remain allied. Some fiber companies have expressed interest and want the towns to have "skin in the game."
- The Board reviewed an undated letter from Don Ripley regarding the proposed levelling of his camp at 12 Waugh Road. Creston will write to him and advise him that the Board finds that no permit is required for this (all agreed that this is the case).
- The Board understands that Gary Fuller has resigned as Code Enforcement Officer. The selectmen are looking for a replacement.
- The meeting adjourned at 7:20 PM.

## Planning Board Minutes Continued

June 24, 2020

- At 6:10 PM, the Board met with Matt Siegel on his father-in-law's Flying Pond property, shown on tax Map 11 as Lot 17, to consider his proposal to construct an addition to the existing cabin. He presented a site sketch. A deck, not shown on the sketch, was observed on the easterly end of the cabin, and its effect on square footage calculations was discussed informally, the cabin being non-conforming. Septic system approval is still pending. The cabin and the deck are the only structures on the parcel.
- At 6:40, the said members met with Bill and Anne Eiseman on their Kimball Pond property, shown on tax map 3 as lot 48-K, regarding their proposal to build a new camp on the parcel. The terrain appears fairly flat.
- At 7:00 PM, the said members convened the Board's regular meeting at the Town House. Also present were the Eisekans and Matt Siegel.
- The Eisekans' proposal was considered. They presented SSWD permit # 2020-1 and a site drawing. Based on its on-site observations and the Eisekans' verbal representations, their site drawing, and a subsequent examination of the pertinent flood hazard map, the Board determined that the project as outlined above:
  - (1) Will maintain safe and healthful conditions;
  - (2) Will not result in water pollution, erosion, or sedimentation to surface waters;
  - (3) Will adequately provide for the disposal of all wastewater;
  - (4) Will not have an adverse impact on spawning grounds, fish, aquatic life, bird or other wildlife habitat;
  - (5) Will conserve shore cover and visual, as well as actual, points of access to inland waters;
  - (6) Will protect archaeological and historic resources as designated in the comprehensive plan;
  - (7) Will avoid problems associated with floodplain development and use; and
  - (8) Is in conformance with the provisions of Shoreland Zoning Ordinance (SZO) Section 15, Land Use Standards.
- The Board then voted 4 - 0 to authorize Creston to issue a SZO permit for the project.
- Matt Siegel's proposal was then considered. He has made new measurements and says the total of the cabin and deck are in fact 1288 square feet. Everything is within 75 feet of the shoreline. He noted that SZO Sect. C (1) (c) (i) requires that an expansion in this situation would have to be less than 1000 square feet. He says the cabin was built in 1971 and is not certain whether the deck was there then. He will look into this.
- The addition will not be closer to the water than the existing structure. A revised site sketch was provided. The height of the addition will be lower than that of the existing structure. He is having a site evaluation done on June 25 and will seek to get a SSWD permit. He was advised that some sort of curtain drain may be required to divert runoff.
- The application was tabled until the Board's July meeting.
- Regarding the Craig lots (see May minutes) Wayne noted that emails outlining the Board's position were exchanged with attorney Paul Mills.
- The meeting adjourned at 7:40 PM.

## From the Health Officer

### The Big Test is Here

I've spent my career taking care of patients, teaching new doctors how to do that effectively, and working to set up effective prevention health care systems in Maine. Now we've got the biggest job of all: to help everybody do the preventive maneuvers which can dramatically reduce Covid19 virus transmission. Those maneuvers include moderately uncomfortable **masking\* in addition to distancing, no touching, handwashing, and general careful changing of many lifelong habits**. All ages can suffer consequences; the elderly worst, but a percentage of all age groups get very sick, sometimes unto death. Until we get a vaccine, probably next spring, that's all we've got to protect us! Maine is in great shape right now, compared to most other states; but it is going to be extremely difficult to stay so good as disease and death rates surge in the rest of the country

Several things scare me about our circumstances.

1. I am fearful about our ability to continually monitor and improve our preventive measures if Federal proposals to switch all US medical Covid19 data reporting, mid-pandemic, from the US Center for Disease Control to the US Department of Human Services, without initially running both systems simultaneously for many months. Accurate epidemiologic data is crucial to our success in prevention decision; it allows us to monitor and improve our interventions.
2. I don't understand why many people in Maine decline to follow the personal measures I bolded in the first paragraph. Those same folks, never-the-less, obediently continue to drive on the right side of the road unless passing, a similar community supportive behavior. The country has already had more than 4 million cases and 150,000 deaths; that, by the way is surely an undercount too, given the reported "excess deaths" also being counted. And given the case rate surge in most of the country now, the deaths will quickly exceed 2 million.
3. I worry that when a vaccine becomes available, that those people who already oppose vaccinating children as well as adults against common serious diseases will refuse vaccination for themselves or their children, because they fear a conspiracy by vaccine manufacturers to injure them.
4. I worry a lot about the continued breakdowns in the availability of consistent and speedy testing of high risk, exposed, interstate travelers, or sick people. If test results take 7 days to come back, our ability to find and quarantine those they have exposed in that time.
5. And lastly, I worry that Maine won't be able to remain such a low Covid19 disease rate state, given the national surge around us.

What can you do to help? I suggest:

- Please, please, please, try your best to practice publicly the bolded preventive strategies I list in the first paragraph. And please remain flexible as new science improves on them, as has happened already with mask wearing.
- Ask our congressional delegation to prevent the change in Federal covid19 reporting systems. Changing horses in midstream is rarely a good idea.
- And, the most difficult but important thing to do: Politely ask those you run into around town who are not, to get "on board."

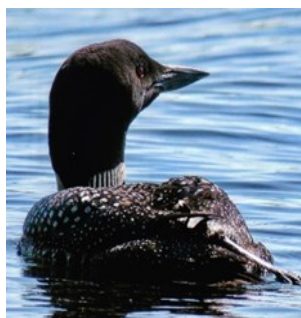
So that's our upcoming big test. Do what you can to help us meet it effectively.

*\*I admit, easy for me to say; we docs are more used to it than the average person, but by scientific studies, wearing a mask is clearly good prevention for both the wearer and those around you (see last month's newsletter for details).*

### LakeSmart

30 Mile is a regional coordinator of LakeSmart, a statewide program led by Maine Lakes. This education and reward program helps lakefront homeowners manage their properties in ways that are lake-friendly and protect water quality. The program is free, non-regulatory, and voluntary.

#### How does it work?

First, a homeowner requests a free site visit. Trained volunteers then perform a property assessment to help homeowners understand what is working well and what could be improved.

Homeowners receive individualized suggestions for keeping pollutants in stormwater and septic systems out of lake waters. Sites that score well earn the coveted LakeSmart Award and distinctive signs that can be posted at the waterfront and driveway, identifying the homes of good stewards and illustrating what lake-friendly living looks like.

30 Mile currently works with volunteer teams on Androscoggin Lake, Parker and David Ponds, and Lovejoy Pond. We hope to soon have teams that cover every lake and pond in our watershed.

## Dr. Shaw Memorial Library News

We are starting a limited opening of the library building as of Saturday, August 1st. We plan to open to the public on Saturdays from 10AM – 3PM, beginning August 1. We will be following CDC guidelines as well as recommendations set by the Maine State Library, as follows:

- Wear a face mask at all times. If you are unable to wear a face mask, we will provide curbside service for you.
- Keep social distance of at least 6 feet from other people.
- Children should stay with their parent or guardian at all times.
- Touch as few surfaces as possible. If you touch materials and decide you don’t want them, we will have stations (boxes or tables) where you can leave them, rather than putting them back on the shelf.
- Visits to the library should not exceed 20 minutes.
- Use hand sanitizer when entering the building.
- Bathroom will not be available to the public.
- Limit socializing to the outdoors. You can use the picnic table or the porches.
- When you first enter, please check for more updated or specific information on how to use the building safely.
- Please limit any use of public access computers to 20 minutes. If extended time is needed, please let us know ahead of time so we can try to make arrangements.

Curbside service will continue on Saturday mornings. If you use our curbside arrangement, please email us ([DrShaw@shaw.lib.me.us](mailto:DrShaw@shaw.lib.me.us)) your requested items by 10AM on Wednesday mornings, for pick up between 9-12 on Saturday mornings. You can also phone us at 293-2565 on or before Wednesday mornings, to place an order.

Interlibrary loan will start again on August 8. You can ask us to request materials from other libraries, and we will place the order. We will quarantine materials for several days when they arrive, and will call or email you for pickup when they are available.

Late this month, the older part of the building where all the children’s and young adult materials are, as well as audiobooks and videos, might not be accessible due to planned renovations happening in those areas. Staff will probably be able to supply materials from those spaces upon request. We’ll keep you posted on when this will occur.

Staff will be working at the library on Wednesday mornings, though the building will be closed to the public. Please feel free to call or email us at that time, if you have any questions or requests for materials.
